Revised 2023 JDC Budget Proposal

Homeowners recently received their Fee invoices for H2 of 2023. Open Cabrera has done an assessment of the proposed budget for 2023 (€ 301,802) and concluded that the Junta de Compensacion budget should really stand at around €124,550. This could be optimised even further with appropriate management.
